Mandatory for HBR Membership

The National Association of REALTORS® requires REALTORS® to complete ethics training every two years. The current two-year cycle will end **December 31, 2018**.

Failure to complete training during this cycle will lead to:

- Suspension of membership for January and February 2019
- Termination of membership starting March 1, 2019

The course is designed to enhance the standard of professionalism by addressing pertinent issues that are occurring locally in Hawaii with a focus on Duties to REALTORS® covered in the Code of Ethics. After completing this course, agents will understand the Code of Ethics and Standards of Practice and be able to apply these tenets in their professional dealings with clients, the public, and other REALTORS®.

Agents will analyze case studies to identify and resolve the ethical issues related to Articles 15, 16 and 17 which focus on making unprofessional comments about other REALTORS®, prospecting other REALTORS® clients, and resolving disputes through mediation and arbitration.

If you became a new member of the Honolulu Board of REALTORS from January 1, 2017 to December 31, 2018 and have completed HBR's New Member Orientation during this period, you have met the NAR Code of Ethics Training requirement.
