Minimum Requirements for serving on the PSAC Committee

1. A REALTOR® candidate shall have been licensed as a real estate agent by the State of Hawaii for five years. A REALTOR-ASSOCIATE® candidate shall have been licensed as a real estate agent by the State of Hawaii for two years.
2. During those years, the candidate shall have practiced real estate in a full-time capacity, shall presently be practicing full time and shall have been a member in good standing of the Honolulu Board of REALTORS®.
3. A REALTOR® candidate shall have completed a minimum of forty real estate transactions. A REALTOR-ASSOCIATE® candidate shall have completed a minimum of twenty real estate transactions.
4. The interviewing committee shall reserve the right to modify the transactions requirement for licensees practicing in real estate specialty areas, e.g. sales managers, brokers-in-charge, property managers, and commercial sales and leasing agents.

Minimum Requirements for serving on the GRIEVANCE Committee

1. The candidate shall have been licensed as a real estate agent by the State of Hawaii for two years.
2. During those years, the candidate shall have practiced real estate in a full-time capacity, shall presently be practicing full time and shall have been a member in good standing of the Honolulu Board of REALTORS®.
3. The candidate shall have completed a minimum of twenty real estate transactions.
4. The interviewing committee shall reserve the right to modify the transactions requirement for licensees practicing in real estate specialty areas, e.g. sales managers, brokers-in-charge, property managers, and commercial sales and leasing agents.
