Training

Eligibility

- Full-time residents occupying their primary residence in the State of Hawaii
- 18 years of age or older
- Demonstrated loss of income directly resulting from the COVID19 pandemic
- No asset limit
- Current household gross income of at 100% AMI or below
 - Chart is on the next slide

Eligible Expenses



- Rent, Home Owners Association (HOA) Dues, Mortgage - between the months of August 2020 to December 2020.
 - Phase 2 is being launched to address March 2020 to July 2020 rent.
 - Launch date is TBD.
- Mortgage and HOA assistance can be requested if it prevents foreclosure
 - Delinquency notice + Trial/Temporary Loan Modification offer letter, may be applicable for certain situations
- Maximum mortgage/rent assistance for Oahu is \$2,000.00/month/household
- Maximum mortgage/rent assistance for Neighbor Islands is \$1,500.00/month/household
- Maximum HOA assistance is \$500.00/month/household (can be stacked)
- Payment will go straight to the Vendor
- We cannot pay for a month that has already been paid for by applicant or another entity
- We cannot duplicate assistance so please inform applicants that they should **ONLY APPLY** through you, or if they did it on their own – to do it on their own again and not through a partner



Other Services

- If applicant would like Financial Counseling Services, program can help pay the fee up to \$150.00 for initial consultation
- If applicant has a Loan Modification Service, program can help pay the fee up to \$400.00 total consultation
- If applicant seeks mediation services, program can help pay up to \$500.00 for mediation session (part of Phase 2 launch)



Documents

- Please collect ALL documents BEFORE completing and submitting the application:
 - Valid Government issued ID for Main Applicant
 - Social Security Card for ALL adults
 - If you do not have a SS Number – Valid Gov ID will be in lieu of SS card. Substitute last 4 of ID in the application for last 4 of SSN.
 - Documentation of loss of income due to COVID19 (employment lay off/furlough letter, closure ,etc.)
 - For all household members receiving income: 2 most current paystubs from application date, UI/PUA benefit statement, TDI, interest, pensions, Social Security, Disability, Welfare/TANF, etc.
 - Please let CCH or a partner agency know if household experiences hardship obtaining income documents
 - SNAP (Food Stamps) is NOT included



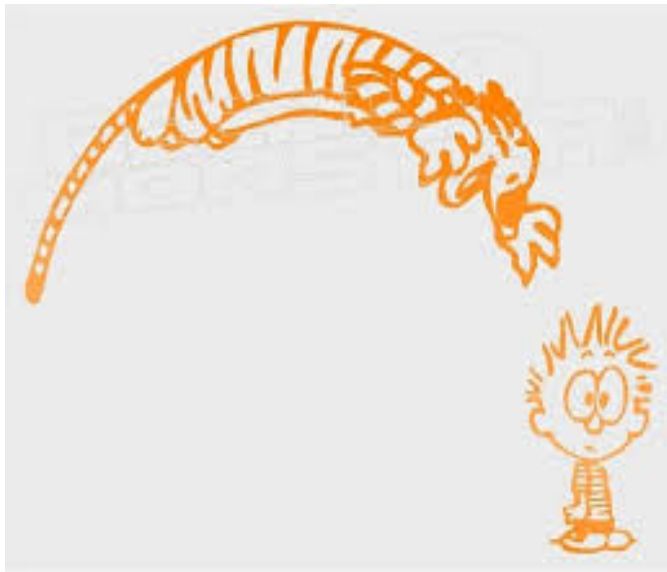
Documents Continued...



- If applying for Rent, please submit Valid Lease/Rental Agreement
- If applying for Mortgage and/or HOA, please submit your most recent monthly statement for each
 - Mortgage/HOA Delinquency notice + Trial/Temporary Loan Modification offer letter, may be applicable for certain situations
- Other documents may be requested to help verify situation



Other Things to Be Aware of



- We cannot pay for households that pay their rent based on their income . If your rent changes when your income changes, you are ineligible.
 - This includes but not limited to: Section 8 vouchers, Hawaii Public Housing, “30% housing”, etc.
- We cannot pay a family member of the applicant unless there is a valid lease/rental agreement. Please click [here](#) if one needs to be completed.
- We cannot pay late fees
- Eviction moratorium for non-payment of rent is scheduled to be lifted end of 09/30/2020
- Plus Up (stimulus) Unemployment Benefit (\$600.00) ended (this may change)
- If an applicant is going through AUW or an AUW partnered agency, depending on where they are at in applying, they should stay with AUW. We leave that determination to you.
