



## ACT 17 (SB 2919)

#### Aloha Nonconforming Certificate (NUC) Registrants:

NUC RENEWAL is between September 1 and October 15 of every year. In August 2024, an on-line renewal link will be emailed to the address(es) we have on file. Note: The renewal process must be completed by October 15, 2024.

Failure to comply with the due date will result in the automatic loss of the NUC.


